The use of highly trained rescue technicians from across the nation is a highly valuable concept in firefighter rescue, however it has been a rocky start. After Action Reports like those found on https://www.wildfirelessons.net usually describe the use of REMS teams as too slow, over-burdened with gear, and rescues being too "gear intensive".
								The problem lays with typical municipal fire departments being asked to perform rescue in a new environment that they aren't used to and don't train in. When the big red truck with all the gear isn't there as your favorite "bomb proof" anchor, and you are performing high-risk rescue away from your fire tower (where you know where all the anchors are), teams are failing very short. The focus of my topic will look at and cover light-weight rescue in austere environments. How to better train our firefighters how to more properly employ hasty rescue in Volatile, Uncertain, Complex, Ambiguous, Time-constraining, and Threat-containing environments (VUCA- T2). An understanding of their responses can be a great asset for firefighters in sizing up a fire, organizing a building evacuation, or managing a catastrophic event. This class teaches how civilians typically react to the stress and uncertainty of a fire or other threatening situation and provides firefighters with a guide to safely managing them. Videos, case studies, and personal fire ground experiences are used to highlight the genetic and social factors that determine human responses to danger. Practical, hands-on tactics designed to facilitate search and evacuation, improve fire alarm response, guide people in smoke conditions, and enhance safe crowd control are discussed along with high rise challenges and means of improving stativay movement. Civilian behavior at incidents such as the 9/11 World Trade Center terrorist attack, the Station nightcub fire, the Beverip Hills supper club, and my own personal fire experience is analyzed. That year, we had 5510 calls for service. A private study revealed that in comparison to similar size departments, our call volume was higher than the regional median. Our call volume increased 16.9% over 5 years, compared to the population of 13.7%. On the EMS side, we showed that 78% of our overall calls for service were EMS/Rescue related, with falls accounting for 40% of our EMS incidents. Most fall incidents were caused by slip/tip falls in older adults at ground level with no injury. As the older adult population prepresented only 6.7% of our population, we also knew we had numerous repeat callers for emergency service. We identified over 60 patients that had called 911 more than 6 times in a month. We found that about 3% of our patients were responsible for 30% of our ambulance calls. As a result of the community risk assessment and analysis, we decided to develop a multi-faceted community risk reduction (CRR) plan. The approach relied on combining the "Es" of CRR in tandem throughout the community, but especially for the types of incidents we identified as provides. We decided to call this the Pasco Resource Navigator program or PRN. PRN is a medical abbreviation meaning "as needed". Our incident data also showed that 35% of our structure fire calls were cooking-related fires. This is mentioned because one of our CRR goals was to reduce cooking fires. Later, we will talk about how these two programs crossed paths more than we realized they would. Education: We partnered with Meals on Wheels for home safety programs. We found many community agencies to build a network of referral resources. We do home safety programs. We found many commonic incentives: Increased the use of equipment to reduce falls. Despite improvements in protective clothing, improved building designs and general firefighting training, firefighter deaths remain relatively consistent from year to year. Research based upon a study of 149 fatal fireground incidents involving volunteer firefighters, totaling 176 deaths, identifies seven broad categories in-which firefighters perished.
								This session identifies those seven categories, breaks down the data, identifies common themes in each of the fatalities and provides realistic methods to aid in the prevention of similar tragedies in the future.
								Understanding how firefighters have died in the past can inform, educate and prepare fire crews from repeating similar mistakes and suffering the same tragic result. The research data clearly shows that fatal events that occurred in 1998 are continuing to occur today despite numerous firefighting improvements.
								So, what's missing?
